Section 1

The Masaryk University Internal Wage Regulations have been modified as follows:

- (2) These modifications to the Masaryk University Internal Wage Regulations were negotiated with the Masaryk University coordinating union committee on 26 March 2018.
- (3) These modifications to the Masaryk University Internal Wage Regulations enter into force in accordance with section 36, subsection 4 of the Higher Education Act on the day of registration with the Ministry of Education, Youth and Sports.
- (4) These modifications to the Masaryk University Internal Wage Regulations enter into effect on 01 July 2018.
