## **Current Legal Issues**

After 5 "more or less" 6 quiet years Internet Governance is again a hot topic of discussions: new gTLDs, Facebook, Google, net neutrality, cloud computing, internet of things, WikiLeaks, content blocking, user blocking etc. E-commerce is still growing but the required legal regime is difficult to establish and maintain. However, motivation is strong due to Latin adage "ubi commercium, ibi jus". This lecture will deal with questions of e persons, e-transactions, jurisdiction and major problems of internet governance (IP numbers, domains, internet protocol family and related dispute settlement procedures). Topics on the content layer (e.g. telecom and internet service providers, data protection, intellectual property, e-commerce, e-government, etc.) can only be shortly covered.
