







Submission of individual faculties' budgets approved AS faculties






Budget 2015 Strategy of Elaboration

- OPVK programme termination and transfering the employees to RDI programme
- Extention of employments/ workloads reductions/ inelegibility

NPU II – general information



- Government grant program (target-funding) to assist OP RDI priority axis 1 centres during the sustainability period
- Expected to be core (non-investment) budget for CEITEC 2016 2020
 - ✓ Most of reinvestments should be funded from OP VVV and other sources
- Call is not officially open for project proposals yet. Call postponed.
 - ✓ State aid rules being clarified internally on MEYS
 - ✓ Expected call opening date was September 2014
 - ✓ Now expected call opening date November/December 2014




NPU II – OP RDI sustainability commitments





- As an overarching rule, there can be no substantial change affecting the character of the Project during the sustainability period (until December 31, 2020).
- The total amount of salary costs in every single year of the period must not be lower than 60 per cent of the highest yearly amount of salary costs covered by OP RDI
- Jobs created within the Project (OP RDI) equivalent to 100 per cent of FTEs as of December 31, 2015 must be kept (460,90 FTE whole project),
- Milestones and other commitments under the Technical Annex must be fulfilled
- Monitoring report on sustainability must be submitted annually including monitoring indicators

NPU II – financing structure




NPU II – current state



- CEITEC in cooperation with other centres is now negotiating possible changes of NPU II criteria with MEYS
- NPU II is one of the key financial instruments of sustainability period
 - ✓ project proposal must be approved in 3Q/4Q 2015
 - ✓ funding from 1. 1. 2016
 - ✓ the data collection procedure is suitable to prepare in advance
- CEITEC seems to be in the most advantageous phase of the NPU II preparation in comparison with other PA 1 OP RDI



NPU II – data collection procedure



- Proposed to collect primary data through a cross-section of individual RP (description of the scientific objectives and strategies)
- The number of scientific results for the whole period of sustainability of CEITEC will be estimated and subsequently the numbers of results related to NPU II project regarding to financial obligations and benefits for the project will be determined
- Defined plan:
 - 1. The first integration of available data will be made at the level of CMS with cooperation with selected OU representatives
 - 2. Revision by the RPC, including a sub-objectives
- Time frame: till the end of November 2014 point 1 and 2 above will be prepared and further scope of work with related documents will be specified
