# 1) Evaluation interview with the MU management / P. Plevka

On January 15th, the regular annual evaluation interview with university management is scheduled. The management members deliberated on the initial draft of the background report, with a particular emphasis on financial sustainability. This aspect will be prominently featured in the final report and on-site presentation.

# 2) Any other business

# a. Opening group leader position 2024 / N. Kostlánová

Based on the previous assignment, N. Kostlánová drafted the advertisement for the position of group leader in life sciences. The recruitment procedure will be launched in January with the acceptance of applications by mid-April. Interviews are scheduled for May/June, and the negotiation phase will take place during the summer. This timeline aligns with the deadlines for ERC applications in September. The start-up grant will be negotiated, with the expected commencement of the group in 2025.

The advertisement for the group leader in life sciences will be launched according to the presented timeline.

#### b. Honorary doctorates update / N. Kostlánová

N. Kostlánová provided an update on the preparation of honorary doctorates. Contact has been established with both candidates who expressed their consent to the nomination. Anticipating ceremonies in 2024 and 2025, CEITEC will cover travel and accommodation costs. E. Jarour informed about a grant scheme from the Ministry of Foreign Affairs expected to cover such costs.

Irena Rektorová applied for total budget 2 365 th. CZK instead of the 1 887 th. CZK allocoated on 2024 according to the novel budget rules.

#### d. Velvet Innovation Meet-up / H. Jílková

H. Jílková provided additional information regarding hosting the Velvet Innovation Meet-up event at CEITEC in March 2024. The event is open to anyone in the innovation ecosystem. H. Jílková will internally promote the event at CEITEC.
