#### 1) Report: Phishing Attack by ICS MUNI 2024 / M. Pokorná

# Context:

- A. Dvořáková presented the results from the analysis of compliance with the systemisation rules according to Director's Measure 4/2019.
- There is an increasing number of group leaders have shared workload with faculties. Two group leaders have workload lower than 0.5 FTE and two groups exceed the maximum size limit for research groups.

Number of employees of CEITEC MU and other MU units with an ORCID identifier were presented at the MU Open Science Strategy Working Group meeting. According to the presented graph, CEITEC MU showed only a minimal number of employees with ORCID, which does not correspond to the assumptions. N.
