Directive N. 9/2008

on completion of full education in the Bachelor's, Follow-Up Master's and Master's degree programmes

Pursuant to Section 2, Subsection 2, Letter d) of the Rector's Directive N. 1/2007 (Principles of creation and issuance of the internal norms of Masaryk University) and to the application of Sections 22, 23 and 24 of the MU Study and Examination Regulations of 13 April 2006 to the conditions of the Faculty of Economics and Administration I issue this directive.

Section 1 Subject-matter of regulation

The subject-matter of regulation is information concerning completion of full education in Bachelor's, follow-up Master's and Master's degree programmes.

Section 2

Final state examination in Bachelor's degree programmes

- 1. The final state examination is composed of the following separately rated parts
 - a) "Defence of the Bachelor's thesis";
 - b) "Final state examination in economics";
 - c) "Final state examination in a specialist course";
 - d) "Final state examination" for the field of study of European economic, administrative and cultural studies

2. A student may undertake the "Defence of the Bachelor's thesis" and take the "Final state examination in a specialist course" upon the fulfilment of all study obligations prescribed for the given field of study. The undertaking of the "Defence of the Bachelor's thesis" and the "Final state examination in a specialist course" is not limited by a condition of completion of the "Final state examination in economics". The student may take the "Final state examination in economics" at any moment during their studies upon the completion of the courses of "Microeconomics I" and "Macroeconomics II".

Section 3 Final state examination in Master's and Follow-up Master's degree programmes

1. The final state examination is composed of the following separately rated parts:



- a) "Defence of the Diploma thesis";
- b) "Final state examination in economics";
- c) "Final state examination in a specialist course";
- d) "Defence of the written work" at the Institut de Preparatation a Administration Generale (IPAG) at the University of Rennes I is prescribed for the students of the study field of Administration Publique

Section 4 Dates of final state examinations

1. The period for announcing of dates of final state examinations is stipulated for the given year by the Time schedule of the academic year. The "Defence of the Bachelor's thesis" and the "Final state examination in a specialist course" are performed on the same day, on a date announced in conformity with the MU Study and Examination Regulations by the department supervising the given field. The dates of the "Final state examination in economics" are announced for the teaching period of the autumn and spring semesters in conformity with the MU Study and Examination Regulations. The dates of the final state examinations are announced through the MU Information System; students register for the individual exam dates using this application.

Section 5 Final provisions

- 1. This directive replaces the provisions of chapter 3.3. "Final state examinations" of the study catalogue for the on-site mode of study for the academic year of 2007/2008 and chapters 3.2.3, 3.2.4 and 3.2.5 the "Final state examination in Bachelor's degree programme" and chapters 3.3.3, 3.3.4 and 3.3.5 "Final state examination in Master's degree programme" of the Study catalogue for the combined form of study for the academic year of 2007/2008.
- 2. I delegate the interpretation of individual provisions and continuous update of this Directive on the Vice-Dean for Studies.
- 3. The Study Department is authorized to perform inspections of adherence to this directive.
- 4. This directive takes effect on the day it is issued.
