

Measure of the Faculty of Economics and Administration, MU No. 3/2018

Scholarship program for the evaluation of publication results of doctoral study programme students

(as amended with effect from 1. 3. 2024)

Pursuant to Section 28 (1) of Act No. 111/1998 Coll. on Universities and a change and amendment to certain other acts (the University Act), as amended (hereinafter referred to as the "University Act") I hereby issue this measure:

Article 1

Purpose of the Scholarship Programme

- (1) The purpose of the scholarship programme is to appreciate and support students who achieve quality publication results and thus contribute to increasing the scientific and research performance and prestige of the MU Faculty of Economics and Administration.

Article 2

Term of the Scholarship Programme

- (1) The scholarship programme is announced for the period from 1. 3. 2024 until revoked.

Article 3

Conditions for Awarding and of a Scholarship Amount Calculation

- (1) The scholarship is awarded to students in the standard period of study (+ 1 year) of the doctoral study program at the Faculty of Economics and Administration, MU, for publications of the "article" type that are published (i.e. have an issue and page number or are published in advance online).
- (2) For the calculation of the amount of the scholarship, the provisions of Articles 2, 3 and 4 of Guidelines of the Faculty of Economics and Administration of Masaryk University no. 2/2024 apply similarly.

Article 4

Scholarship Application

- (1) The scholarship application is submitted by the student via the Document Office in the Masaryk University Information System, where he/she selects the relevant agenda of the scholarship application for the award of publication results.
- (2) The application shall contain the following particulars:
 - a) the name and surname of the applicant,
 - b) his/her UČO,
 - c) the study programme,
 - d) the research focus of the dissertation,
 - e) the semester of study,
 - f) the type of publication,
 - g) the full citation of the publication according to the standard,
 - h) the focus of the publication,

- i) the code and title of the research project under which the publication was produced,
 - j) the website where the text is electronically accessible,
 - k) the signature of the applicant.
- (3) The application must be accompanied by:
- a) A proof of a record of the publication in the MU IS (certifying that the publication was marked for sending to the RIV);
 - b) A copy of the published text of the publication, including a link to the source in which it was published (DOI or URL, or a link to the journal).
- (4) The collection of applications is administered by the Research and Projects Office of the ECON MUNI.
- (5) The Vice-Dean for Research decides on the award of a scholarship.

Article 5
Source of Funding

- (1) The source of funding is the scholarship fund of the faculty.

Article 6
Final Provisions

- (1) This measure repeals the Measure of the Faculty of Economics and Administration, MU No. 3/2018 of 3 March 2023.
- (2) I entrust the Vice-Dean for Research with the interpretation of individual provisions of this measure.
- (3) Compliance with this measure is monitored by the relevant doctoral study coordinator.
- (4) This measure belongs to the methodological management area "Study matters and fees related to doctoral programmes".
- (5) This measure comes into force on the date of signing.
- (6) This measure comes into effect on 1. 3. 2024.
