

Measures of the Faculty of Law of Masaryk University No. 6/2022

**About remuneration in internationally recognised
course programmes**

(as amended with effect from 24 October 2022)

Pursuant to Section 28(1) of Act No. 111/1998 Coll., on Higher Education Institutions and on Amendments and Additions to Other Acts (the Higher Education Act), as amended (hereinafter referred to as "the Act"), I issue the following measure:

Article 1

Introductory provisions

This measure determines the amount of remuneration for activities carried out in programmes of internationally recognised courses (hereinafter also referred to as programmes), which are carried out pursuant to §60a of Act No.111/1998 Coll., on Higher Education Institutions and Amendments and Supplements to Other Acts (Act on Higher Education Institutions), as amended. Remuneration is paid for the provision of teaching and related tasks.

Article 2

**Amount of
rewards**

The gross remuneration is set out in Annex 1. Remuneration is proposed by the Vice-Dean for Bachelor's and Master's Studies and Lifelong Learning on the basis of the reported activities of individual staff members. Administration is provided by the Centre for Continuing Education.

Article 3

Final provisions

- 1) This measure cancels Dean's Measure No. 8/2017.
- 2) That measure takes effect on 24 October 2022.
- 3) I entrust the interpretation to the Secretary of the Faculty.
