MEASURE No. 5/2020 FACULTY OF PHARMACY OF MASARYK UNIVERSITY

Fees for Advanced Master's Proceedings

(in the version effective from 9 February 2020)

In accordance with Section 46(5) of Act No. 111/1998 Coll., on Higher Education Institutions and on Modification and Amendment of Other Acts (Higher Education Act), as later amended (hereinafter referred to as the "Act"), and in accordance with the Study and Examination Regulations of Masaryk University (hereinafter referred to as the "Regulations"), I issue the following Measure:

Article 1

Basic Fees in Czech and English Programmes

(1) In accordance with section 46(5) of the Higher Education Act, the fixed fees of the faculty for acts connected with the acceptance of the application for the advanced Master's state examination and with the organisation of this examination in the Czech language amount to CZK 8,700, and in the English language to EUR 1,900. This basic fee includes the administration of the advanced Master's proceedings, the initial consultation with the chair of the advanced Master's examination board, the organisation of the advanced Master's state examination of reviewers and the defence of the advanced Master's thesis, and the organisation of the graduation ceremony.

(2) Applicants who request a professional consultant shall pay, in addition to the basic fee, CZK 6,000 for consultations in Czech, and EUR 500 for consultations in English. The fee includes consultations with a selected expert in the field and a final revision of the advanced Master's thesis before its submission.

(3) Applicants who require a professional consultant and at the same time use instrumentation and laboratory equipment shall pay CZK 12,000 if the Czech language is used, and EUR 1,000 if English is used, in addition to the basic fee for consultations and guidance in the laboratory. As part of the fee, the candidate shall not only have the opportunity to use the faculty's equipment and laboratories for their research, but also professional guidance in the experimental and theoretical part of the thesis, including the final revision of the thesis before its submission.

(4) The fee for a resit of the advanced Master's exam or part thereof in Czech is CZK 2,000; for a resit in English it is 200 EUR. The resit fee must be paid no later than 7

working days before the date determined for the resit of the advanced Master's examination on the basis of an invoice issued by the Finance Office of the Faculty of Pharmacy.

(5) The fees can be paid through the Shopping Center in the Information System of Masaryk University.

Article 2

Common, Transitional and Final Provisions

- (1) This Measure repeals the Measure of the Faculty of Pharmacy of Masaryk University No. 5/2020 "Fees for Advanced Master's Proceedings" of 24 September 2020, effective from 24 September 2020.
- (2) This Measure shall enter into force on the day of its execution.
- (3) This Measure shall enter into effect on 9 February 2021.
