- 1. From menu find Customer Cards (from Menu Sales and Order processing)
- 2. See the list of the customers using key F5 .Go to the 1st one and last one
- 3. Chose Customer with the number 30000 by use of the filter F7
- 4. Find all customers with currency code USD
- 5. Find all customer with language code ENU
- 6. Find all customers using currency ZAR
- 7. Observe the calculation field balance and see Entries by Ctrl-F5
- 8. Where you can also find entries using button cccc-F5 ? Find key combination from buttons and Help as well!
- 9. ESC back to the card and find Payment condition!
- 10. How you can change to 3 weeks? 35 days?
- 11. Using Help button or F1 when staying on field Payment Condition and try to understand what does that means! How you can enter 14 days ? 5 weeks ?
- 12. Go back to Customer ledger entries and go the last invoice created
- 13. Show the document whose posting was the reason why the entry of the Type Invoice was created! Use Navigate!
