Activities:

- 1. Name of team members and your chosen topic:

 - ii. your written HANDOUT (Summary)
 - 1. **Handout requirements:** (extract of Syllubus and adapted)
 - a. Handout is short it has a minimum of 2 page and maximum of 3 pages (A4: 2.5 cm margins, font 12b)
 - b. Contains important information based on the content of the presentation. Mentioned is especially key factual knowledge, which is dedicated enough space (as discussed in more detail, describe practical impact, etc.). Less important things are not mentioned at all or represented by a link to more detailed resource.
 - c. Handout is structured. Single logical units are graphically separated. Bullets or short paragraphs prevail.
 - d. Handout is understandable. Every technical term is explained (in parentheses) or footnote.

- e. Important theories are explained in detail, less important, are not listed or are briefly explained.
- f. Handout is professional. Based on the scientific or professionally recognized literature, which is cited in accordance with citation standards (we recommend putting in brackets the author's name, and year of publication) - use bibliographical citations according to the APA Style¹. Handout does not contain unverified information, theory and general knowledge gained from popular websites (e.g. hrexpert.com).
- g. Handout includes literature references. See citation of literature in this Syllabus use it as a standard.
