Komunistická Čína


- Radikální rozchod s **hodnotami a institucemi**;
- **Malý skok kupředu** (1949-1957): kolektivizace, obilní monopol a omezení pohybu;
- **Velký skok kupředu** (1958-1962): komuny (produkce železa), hladomor;
- Oslabení Mao Ce-tunga (1959) - ultralevicová klika a **Kulturní revoluce** 1966-69, 1976 (vyčištění od kontrarevoluce – rozklad);
- **Reformy** Teng Siao-pching 1978:
 - **decentralizovaná ekonomika**; **rodinné farmy**, **lokální management** průmyslu, **soukromé SME** podniky;
 - **socialistický princip** – kolektivní vlastnictví **velkých podniků** (zisk); cíl **socialismu** – eliminace chudoby; investice z **státních bank** do průmyslu a ELG;
- Od 2000 **zvláštní ekonomické zóny** (tržní ekonomika);
- V 80.letech **růst** HDP 10%, v 90. letech 7,5%, po roce 2000 v průměru 9,5% (do 2015 růst 10%).












Od reforem k exportu socialismu s čínskými charakteristikami

- **Teng Teng Siao-pching** (1978-1989): „hide your strength, bide your time, **never take the lead**“;
- **Ťiang Ce-min** (1993-2003): „...**moderately prosperous** country“;
- **Chu Ťin-tchao** (2003-2013): „**harmonická společnost**“ – reindustrializace a modernizace;
- **Si Ťin-pching** (2013-): prosperující společnost v 2021 (KSČ) a **plně rozvinutá země** v 2049 (ČLR); 13tý 5letý plán (2016-2020);
 - **vyčerpání catch-up growth** – státní podniky a banky, masivní investice do infrastruktury; exportem tažený růst;
 - **pozitivní zkušenost**: mobilizace kapitálu pro hospodářský rozvoj, investice do infrastruktury, operace státních podniků;
- **Problémy**: nerovnoměrný rozvoj; závislost na produkci pro světový trh; nízká přidaná hodnota; rostoucí mzdy; nadprodukce ve státem podporovaných sektorech (těžký průmysl a stavebnictví); rezervy zahraničních měn;
- **Go Global!; Belt and Road Initiative; Made in China 2025**;
- Připouští **rivalitu** se západem (USA bude blokovat Čínu) – **vývoz čínského modelu** „No strings attached“ ...





China – distribution of workforce



working day adjusted**





Figure 6: Production and labour input indicators for high-technology manufacturing ⁽¹⁾, EU-27, seasonally adjusted (2005=100)

Share in world trade in goods and services in selected countries (%)









KUKA - Keller und Knappich Augsburg (1898)

- KUKA Systems' plants/equipments are being used by various automotive manufacturers such as BMW, GM, Chrysler, Ford, Volvo, Volkswagen, Daimler AG, Valmet Automotive as well as manufacturers from other industrial sectors such as Airbus, Siemens and others.
- In 1973, KUKA created its own industrial robot FAMULUS.
- In June 2016, **Midea Group** offered to buy Kuka for about €4.5 billion (\$5 billion). Midea completed the takeover bid in January 2017 by taking 74.55% voting stake in the company.
- **Midea Group** - produces lighting, water appliances, floor care, small kitchen appliances, laundry, large cooking appliances, and refrigeration appliances (135 thousand employees, 60 affiliates)...



(% of total), 2020






International trade in services with non-member countries (extra-EU), EU, 2010-2020







Share of services within total trade of goods and services, selected countries, 2010 and 2018











Share of services within total trade of goods and services, selected countries, 2010 and 2018






Mode 1: Cross-border supply




Mode 2: Consumption abroad



Trade in services with non-member countries (extra-EU), main partners EU, 2018 and 2019





International trade in services with non-member countries (extra-EU), EU, 2010–2019 (billion EUR)




