## Al Capone - No Subtitle Needed

Al Capone is one of the biggest names in the history of the organized crime. His name does not need nay subtitle as he is unmistakably connected to the Prohibition year in the United States of the 30's. However, he is not only known for his lifestyle and money he made from bootlegging but also for the trial that led to his downfall and death in prison after his conviction.

In our presentation we will focus on Al Capone with a brief overview of his activities and then look over the events that led to the investigation and conviction.
