

04	contacted Pittsfield Township Police Department after receiving					
05	notification of our search from the Dewitt Police Department. Det.					
06	sgt. McRell spoke with Suspect, Nosal and she agreed to					
07	immediately respond to PTPD for an interview. On arrival, Suspect/

15	her rights, per Miranda, and chose to waive them (waver attached).					
16	Suspect/ Nosal . denied the allegations made against her and provided

19	and woke up at approximately 8:00 AM. Suspect/ $Nosal$ , a Michigan					
20	State Univ. graduate student in agriculture, stated that, at

22	pots. After collecting those items, Suspect/NOSal indicated that					
23	she went to the fields near College Road, Beaumont Road and Jolly Road					
24	to collect weed samples for her study. She related that she worked in					
25	the fields from 8:30 AM to 9:30 AM, but quit because of bad weather
