# Terminology


- *Pos(t)+sedere = possidere*
  - Factual domination over a thing
  - *Possessor*
  - *Ius possidendi* as a part of ownership triad
    - cf. it. *possedere*, eng. *possessions*
    - *Possessio ac ususfructus agri provincialis*
  - *Beati possidentes*
  - *Usucapio*

# Requisites

- *Animus possidendi (animus rem sibi habendi)*
  
- *Corporalis possessio (corpus possessionis)*

# Gaining of a possession

- *Animo utique nostro,*
  - *Subjective part, subjectively incapable does not have it*
  - *impuberis tutore auctore*
- *corpore vel nostro vel alieno.*
  - *servus*
  - *personae alieni iuris*
  - *in Iustinian times per liberam personam*




# Means of a gaining

- *Occupatio* (not concerning the will of the previous owner)
  - *Traditio* (=derivatively)
    - *apprehensio, omnes glebas circumambulare*
    - *traditio ficticia/symbolica, vacuam possessionem tradere usque ad terminum*
    - *traditio longa manu (ex turre)*
    - *traditio brevi manu* (a change of *animi* in case of detention)
    - *constitutum possessorium* (the owner sells a thing, but keeps it in a detention, the acquirer gains possession)

# Extinguishment of a possession

- Death of the owner, without heirs, or extinguishment of a thing
- Missing of one of the requirements, but
  - *possessio animo retinetur*
  - *saltus hiberni et aestivi*
  - *servus fugitivus*




## *Interdicts concerning possession*

- *Interdicta adipiscendae possessionis* - to claim gained things
    - *interdictum Quorum bonorum* - for the possessor of the inheritance
    - *interdictum sectorium* - for the winner of an auction
    - *interdictum Salvianum* - for the gain of the inventory in case when rent has not been paid
  - *Interdicta retinendae possessionis* - protection of possession in court
    - *interdictum Utrubi* - movables, in last year
    - *interdictum Uti possidetis* - immovables
  - *Interdicta recuperandae possessionis* - final decision
    - *interdictum de vi* - *intra annum*
    - *interdictum de vi armata* - even gained *vi, clam, precario*
    - *interdictum de precario* - 30 years

# Means of controlling a thing

- Possession
  - Detention (*possessio naturalis/corpore/pro alieno*)
    - Protection through owner
    - e. g. depositary, *conductor*
  - Derived possession
    - Protection through interdicts
    - *sequester*, precarium, mortgage
  - Possession of a right (*possessio iuris, quasi possessio*)
    - Factual performance of other rights than ownership
    - Interdicts as a protection of servitudes
