Academic Debate

- The purest form of debate
- No embellishments, merely speeches:
 - No Parliamentary interruptions
 - No heckling (unless specifically permitted)
 - No opportunity to question or be questioned (unless permitted)

Heckling

- When to Heckle
 - To relieve seriousness of the debate
 - To underline weakness of fact or reasoning
- How to Handle Heckling
 - To prevent it
 - To respond with more humorous
 - To ignore

Worlds Style Points of Information

- Used at the Worlds Schools Debating Championships
- Not recommended for novice debaters
- Raised only between the first and final minute of a constructive speech
- Take a form of question or remark
- Must be brief

Rule # 1

- Debaters take sides
 - Affirmative
 - Negative
- Resolution
 - No middle ground; either true or false

Rule # 2

- Debaters take turns
 - Oxford format
 - Cambridge format
 - Lincoln-Douglas format

Oxford format

•	1st Affirmative (constructive speech)	5 minutes	
•	1st Negative (constructive & rebuttal speech)	8 minutes	
•	2nd Aff (constructive and rebuttal speech)	8 minutes	
•	2nd Neg (constructive and rebuttal speech)	8 minutes	
•	3rd Aff (constructive and rebuttal speech)	8 minutes	
•	3rd Neg (constructive and rebuttal speech)	8 minutes	
•	1st Aff (rebuttal speech)	3 minutes

Cambridge format

•	1st Affirmative (constructive speech)	5 minutes	
•	1st Negative (constructive speech)	5 minutes	
•	2nd Affirmative (constructive speech)	5 minutes	
•	2nd Negative (constructive speech)	5 minutes	
•	3rd Affirmative (constructive speech)	5 minutes	
•	3rd Negative (constructive speech)	5 minutes	
•	1st Negative (rebuttal speech)	3 minutes	
•	1st Affirmative (rebuttal speech)	3 minutes	
•	2nd Negative (rebuttal speech)	3 minutes	
•	2nd Affirmative (rebuttal speech)	3 minutes	
•	3rd Negative (rebuttal speech)	3 minutes	
•	3rd Affirmative (rebuttal speech)	3 minutes

LD format

- Affirmative
- Negative Cross-examination
- Negative
- Positive CX
- Affirmative
- Negative
- Affirmative

5 minutes preparation time

- 6 minutes
- 3 minutes
- 7 minutes
- 3 minutes
- 4 minutes
- 6 minutes
- 3 minutes

Constructive speech

■ The affirmative

- May define resolution
- Should state the importance of the resolution and the values it contains
- Should present the reasonable arguments to support the values

Negative

- May dispute the affirmative definitions
- Should attack both the values and the affirmative's interpretation and defense
- May present new values

The Rebuttals

- New evidence to support old arguments
- The affirmative must reply before the last rebuttal
- The responsibility of the speaker to defend and to attack

Cross examination

- Form of questions and answers
- Clarification of an obscure point
- Attitude reasonable, cooperative, eager to please
- Admissions or information must be used in subsequent speeches
- Reasonable length

Rule #3

No Moving Targets

- Every single argument that Affirmative wants to make must be made in the first speech
- No adding of new arguments in later speeches
- Same for Negative
- Development of arguments

Addressing

- In third person by the position
- Opening
 - Mr. Moderator
 - Honorable judges
 - Worthy opponents
 - Ladies and gentlemen

Judging

- Based upon:
 - Skill in analysis
 - Use of evidence
 - Validity of evidence
 - Validity of argument
 - Clarity of organization
 - Effectiveness of delivery
 - Strength and conviction

May the best win

- Single-sex schools are good for education
