Bibliometrie

- Bibliometrie měří, sleduje a analyzuje vědeckou literaturu (ROEMER a BORCHARDT 2015)
 - Pritchard (1969) explained the term ***bibliometrics*** as “the application of mathematical and statistical methods to books and other media of communication”.
 - Nalimov and Mulchenko (1969) defined ***scientometrics*** as “the application of those quantitative methods which are dealing with the analysis of science viewed as an information process”.
- Cíl bibliometrie:
 - Dříve spíše pro knihovny (rozvoj fondu), nyní pro hodnocení/financování vědy a strategické rozhodování (mimo kontext vzniku).

Journal Impact Factor Calculation

How is Journal Impact Factor Calculated?

$$\text{JIF} = \frac{\begin{array}{l} \text{Citations in 2019 to} \\ \text{items published in 2017} \\ (40,796) + \text{2018} \\ (33,725) \end{array}}{\begin{array}{l} \text{Number of citable items} \\ \text{in 2017 (838) + 2018} \\ (904) \end{array}} = \frac{74,521}{1,742} <$$

Article Influence Score/EigenFactor Score

Calculating Eigenfactor Score and Article Influence Score

The 2006 JCR indexes the citations from 7611 "source" journals for the Sciences and Social Sciences. From these data, we extract a 5-year cross citation matrix \mathbf{Z} . For 2006, the entries of this matrix would be:

\mathbf{Z}_{ij} = Citations from journal j in 2006 to articles published in journal i during 2001–2005.

When constructing \mathbf{Z} , we omit all self-citations², setting all of the diagonal elements of this matrix to 0. We normalize \mathbf{Z} by the column sums (i.e., by the total number of outgoing citations from each journal) to create a column-stochastic matrix \mathbf{H} :

where X = 5-year Journal Article Count divided by the 5-year Article Count from All Journals.

CiteScore

CiteScore 2016 methodology



CiteScore 2016 counts the citations received in 2016 to documents published in 2013, 2014 or 2015, and divides this by the number of documents published in 2013, 2014 and 2015.



3-year publication window

The 3-year CiteScore time window was chosen as a best fit for all subject areas. Research shows that a 3-year publication window is long enough to capture the citation peak of the majority of disciplines.

Frequency

Document types

All types of documents (research articles, review articles, conference proceedings, editorials errata, letters, notes, and short surveys) are included in the CiteScore calculation. Although articles in press are included in Scopus they are not included in the calculation.

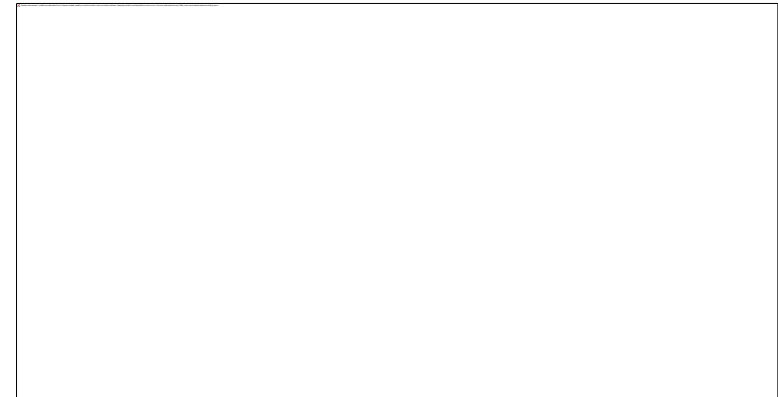
