# BACK TO CORRUPTION PERCEPTION INDEX

WHERE DOES THE DATA FOR ESTABLISHING THE INDEX COME FROM?

Each country's score is a combination of

- at least 3 data sources
- drawn from 13 different corruption surveys and assessments
- collected by reputable institutions, including the World Bank and the World Economic Forum

# CORRUPTION PERCEPTION INDEX

WHAT ASPECTS OF PUBLIC SECTOR CORRUPTION DOES THE CPI MEASURE?

- BRIBERY
- DIVERSION OF PUBLIC FUNDS
- OFFICIALS USING THEIR PUBLIC OFFICE FOR PRIVATE GAIN WITHOUT FACING CONSEQUENCES
- EXCESSIVE RED TAPE IN THE PUBLIC SECTOR WHICH MAY INCREASE OPPORTUNITIES FOR CORRUPTION
- NEPOTISTIC APPOINTMENTS IN THE CIVIL SERVICE
- STATE CAPTURE BY NARROW VESTED INTERESTS

WHAT ASPECTS OF PUBLIC SECTOR CORRUPTION DOES THE CPI MEASURE?

Cont.:

- EFFECTIVE PROSECUTION OF CORRUPTION CASES
- ADEQUATE LEGAL FRAMEWORKS, INCLUDING LAWS ENSURING THAT PUBLIC OFFICIALS MUST DISCLOSE THEIR FINANCES AND POTENTIAL CONFLICTS OF INTEREST
- ACCESS TO INFORMATION ON PUBLIC AFFAIRS/GOVERNMENT ACTIVITIES
- LEGAL PROTECTIONS FOR WHISTLEBLOWERS, JOURNALISTS AND INVESTIGATORS
